DEADLINE FOR APPLYING: September 1

This is a juried show. All work must be original - designed and crafted by the artist **who must be present at the show**. The Arkansas Craft Guild is committed to ensuring the continued quality of items sold at this show. Work displayed and sold at this show must be representative of the work the artist submitted for jury. Jury committee members will be checking booths to ensure the quality and type of the work matches what was submitted. Artists may be asked to remove work from their booth that does not meet these requirements. **A \$25.00 nonrefundable jury fee will be charged, along with booth fees, if you are accepted. We must receive at least a \$100 deposit on your booth before one is reserved.** Guest artists need not be an Arkansas resident.

NEW APPLICANTS: Must submit 5 images of your work and 1 of your booth display and a completed application by email to arkansascraftguild@gmail.com with CHRISTMAS SHOWCASE JURY in the subject line. Pictures should still be submitted by email. If you are unable to email your information, you may send a CD or thumb drive with images of your work and your completed application to Arkansas Craft Guild Christmas Showcase, P. O. Box 800, Mtn. View, Arkansas 72560. The images will be sent to the Christmas Showcase jury committee. You will be notified by email of the jury's decision.
